**SUBJECT: Pair Arrested, One Sought for August 1<sup>st</sup> Armed Robbery**

On Thursday, August 9<sup>th</sup>, 2012 the Newark Police Department arrested 20 year old Jaydeem Maddox of New Castle and 20 year old Jasmine White of Wilmington for their involvement in the August 1<sup>st</sup> armed robbery which occurred on Victoria Court in Newark. Police Investigators are actively searching for a third suspect, Daniel Scott for his involvement in the crime.

Through investigation detectives identified Jasmine White as the get away driver for the robbery. Newark Police executed a search warrant at her home on August 9<sup>th</sup> taking her into custody and locating items linking her to the crime.

Later the same day, Jaydeem Maddox turned himself in to NPD Headquarters after learning that investigators were searching for him. Police Detectives have identified a third subject involved in this robbery as 18 year old Daniel Scott of Wilmington. Warrants are on file for the arrest of Scott. Anyone with information on Scott's whereabouts is asked to contact Newark Police Department.

Detectives have also learned that this investigation was related to a drug deal in which the victim was robbed while attempting to sell marijuana to the Maddox and Scott.

**SUBJECT: Armed Robbery near Haines Street**

On Wednesday August 1<sup>st</sup>, 2012 at approximately 5:45 p.m. the Newark Police responded to the fire lane area of Victoria Court near Haines Street for a report of an armed robbery. Officers made contact with a 20 year old male victim. The victim was walking down the fire lane of Victoria Court when he was approached by two unknown males. The males engaged the victim in conversation. One suspect then pulled out a handgun and the two suspects stole the victim's cell phone and wallet. The suspect fled to a waiting four-door dark green sedan. The victim was not injured.

The suspects are described as follows:

Suspect #1: black male, 18 to 25 years old, 6'01" tall, thin build, wearing a white t-shirt, tan cap, black Nike track pants with a white stripe down the side and black boots.

Suspect #2: black male, 18 to 25 years old, 5'07" to 5'09" tall, large build, wearing a white tank top, black Nike hat, shorts, white calf length socks and dark sneakers.
