

## WEEKLY REPORT

This past homecoming weekend went very well. As always, additional officers were working throughout the weekend. Police officers patrolled on foot, bicycle, and in unmarked vehicles. As a result of the nice weather on Saturday there was a lot of activity for the police. Officers were very proactive and issued noise warnings and occupancy warnings early in the day. This proactive policing resulted in many large and loud parties ending early. A total of 36 arrests were made by officers assigned to order maintenance on Saturday. There were nine arrests for underage consumption of alcohol, six arrests for open containers of alcohol in public, six arrests for noise violations, four arrests for littering, and three arrests for trespassing on railroad tracks. Additional arrests were made for such offenses as resisting arrest, fictitious identification, etc. The officers did a great job, and it was one of the most orderly homecoming weekends within recent years.

The Delaware Department of Highway Safety has awarded the Newark Police Department grant money to fund overtime patrols to combat "Distracted Driving". Officers will target drivers who are using cell phones, as well as any other distracted driving in early December.

The police department promotional ceremony will be held in city council chambers on Friday, November 11<sup>th</sup> at 2:00 p.m. Delaware Supreme Court Justice Randy J. Holland will be the keynote speaker. At the ceremony, Michael VanCampen will be promoted to Captain, Andrew Rubin to Lieutenant, Greg D'Elia to Sergeant, and Wayne Aston to Master Corporal.
